GENERAL INFORMATION

eNtrench NXTGEN is a nitrification stabilizer for use with nitrogen based fertilizers.

DIRECTIONS FOR USE

eNtrench NXTGEN may be used with Urea, UAN and Liquid Manure.

eNtrench NXTGEN may be impregnated to dry granular fertilizer (Ammonium, Urea) and applied as a preplant incorporated fertilizer or in the spring as a postplant with any crop that requires nitrogen fertilization. eNtrench NXTGEN can also be applied postplant (Side Dress) application or applied in tank mixtures with preplant incorporated or pre-emergence herbicides or insecticides. The tank mixes may be in water or in most UAN solutions, N-P-K solutions, slurries, or suspensions.

Apply eNtrench NXTGEN at a rate of 1.75 L/ha.

Liquid Manure application rates 1.75L/ha

Restrictions

Do not mix seed with dry fertilizers impregnated with eNtrench NXTGEN

STORAGE

Keep in tightly sealed closed container.

DISPOSAL
