Range & Pasture herbicides by Corteva Agriscience™ are effective tools in managing weeds, brush and trees in permanent grass pastures and grazed rangeland. **Understanding precautions, restrictions and how to steward Range & Pasture products properly is important to ensure satisfactory results and to protect desirable species and the environment.** In consideration of the sale of Range & Pasture products by Corteva Agriscience or its authorized distributors or retailers, the undersigned acknowledges receipt of the following information, cautions and restrictions.

Grazon™ XC herbicide (active ingredients: picloram and 2,4-D) is a herbicide that provides effective control of a broad spectrum of trees and annual and perennial broadleaf weeds. **Tordon™ 22K** herbicide (active ingredient: picloram) is a herbicide that is very effective for the control of deep-rooted, perennial and biennial weeds. It is essential to manage the use of Grazon XC and Tordon 22K effectively due to their persistent nature and non-selective control of broadleaf plants. **For this reason, Grazon XC and Tordon 22K are sold for use on permanent grass pastures and labeled uses only.**

Reclaim™ II herbicide (active ingredients: aminopyralid, metsulfuron and 2,4-D) is a herbicide that provides effective control of a broad spectrum of woody shrubs and annual and perennial broadleaf weeds. **Restore™ II** herbicide (active ingredients: aminopyralid and 2,4-D), **Restore™ NXT** herbicide with Rinskor™ active (active ingredients: aminopyralid and florpyrauxifen), **Milestone™** herbicide (active ingredient: aminopyralid) and **Milestone™ NXT** herbicide with Rinskor™ active (active ingredients: aminopyralid and florpyrauxifen) are herbicides that provide effective control of a broad spectrum of annual and perennial broadleaf weeds. **For this reason, Reclaim II, Restore II, Restore NXT, Milestone and Milestone NXT are sold for use on permanent grass pastures and labeled uses only.**

CAUTIONS AND RESTRICTIONS:

- Prior to application, read and follow label directions.
- Corteva Agriscience Range & Pasture herbicides are **not** currently registered for application by Remotely Piloted Aircraft Systems (drone).
- Do not apply Range & Pasture herbicides to garden or lawn areas. They are registered for permanent grass pastures only.
- Most grasses are tolerant to Grazon XC, Tordon 22K, Reclaim II, Restore II, Restore NXT, Milestone and Milestone NXT. However, some grasses may show temporary symptoms like yellowing or delayed growth following an application.
- Do not apply any Range & Pasture herbicides to areas where the elimination of legumes or other susceptible species cannot be tolerated.
- When applying Grazon XC and Tordon 22K, leave a buffer zone of at least 1.5 times the height of desirable trees. When applying Reclaim II, Restore II, Restore NXT, Milestone or Milestone NXT stay outside the dripline of desirable trees.
